TCAP-Alt is an alternate assessment based on alternate achievement standards. This assessment is appropriate for students with a significant cognitive disability as determined by the Individual Education Plan (IEP) team. <p>Grade 2 Achievement Assessment (Math and Reading)</p> <p>Grade 2</p>	<p>April 17 – May 2</p> <p>Testing Time: 162 minutes</p>	<p>District - The grade 2 assessment is designed to assess Tennessee State Standards providing teachers and parents information on how students are performing at the end of their 2nd grade year on Tennessee specific standards.</p>	<p>Scores and other information from this assessment are delivered to the schools for distribution. Results are not used for grades.</p>
<p>Grade 2 Alternate Achievement Assessment</p> <p>Grade 2 <i>(select students determined by IEP team)</i></p>	<p>March 13 – April 28</p> <p>Tests are untimed, total time varies based on individual student needs.</p>	<p>District – The Grade 2 Alternate Assessment replaces the TCAP – Alt portfolio assessment, and was designed in a similar process as MSAA. The assessment was designed so that test administration would mimic daily instruction, with teacher interaction, and can be delivered over multiple days in multiple sessions as needed for the individual student.</p>	<p>Scores and other information from this assessment are delivered to the schools for distribution. ACCESS for ELs Grades K-12 <i>(English language learner students only)</i>	February 13 – April 3 (selected EL students) Testing Time: Untimed – approximately 180 minutes	State – States are required to assess the proficiency of all English Learner (EL) students. According to Title III, states are to measure the annual growth of an EL student’s English development in reading, writing, listening, and speaking. Visit WIDA , the EL Assessment site, which also contains information on the standards used for more information.	Scores and other information from this assessment are delivered to the schools for distribution in August. Results are not used for grades.

Civics Assessment Grades 11-12 : students enrolled in Government and Civics and/or JROTC	Assessment date will vary by high school. Please contact your high school for specific dates. Testing Time: Untimed (about 40 minutes)	State – This assessment is designed to measure the civics knowledge and skills of students and to comply with Tennessee State law T.C.A 49-6-408A. Students are required to participate and answer 75% of the questions correctly prior to graduation.	Scores will be reported on Skyward and will not be used as a grade.

Advanced Placement (AP) Grades 9-12 <i>(course specific)</i>	May 1 – May 12 Testing Times: Total times varies depending upon course.	District – The AP exams are final assessments for the corresponding college-level course taken in high school. Scores can be used to award credit or to determine placement upon entering college. Click here for College Board’s AP site.	Scores and other information become available to students online through the College Board starting in July. Results are not used for grades.
ACT Grade 11, 12	October 18 (12 th grade paper/pencil) March 21-23 (11 th grade online) Testing Time: 175 minutes	State – ACT is an achievement test that assesses students’ academic readiness for college. Visit ACT.org for more information. The ACT assessment is a graduation requirement.	Scores and other information from this assessment are available 4 – 6 weeks after testing. Results are not used for grades.
PSAT / NMSQT Grades 9-11 <i>(only interested students)</i>	October 25 Testing Time: 165 minutes	District – PSAT is the National Merit Scholarship Qualifying Test and provides a national benchmark for student achievement. Visit CollegeBoard PSAT for more information.	Scores and other information from this assessment are delivered to the schools for distribution in December. Scores become available online through College Board soon after. Results are not used for grades.

<p>NAEP (National Assessment of Educational Progress)</p> <p><i>(only selected students in grades 4 and 8)</i></p>	<p>October 10 – December 16</p> <p>Testing Time: 120 minutes</p>	<p>National – This test is a national assessment of what America’s students know and can do in various subject areas. NAEP results serve as a common metric for all states and selected urban districts. The assessment stays essentially the same from year to year, providing a clear picture of student academic progress over time. Learn more about NAEP from the National Center for Education Statistics.</p> <p>Visit NAEP for more information.</p>	<p>NAEP does not provide individual scores for the students or schools assessed. NAEP provides results about subject-matter achievement, instructional experiences, and school environment, and reports these results for populations of students and subgroups of those populations. These results are reported approximately six months after testing.</p>

WIDA Screener for EL Status K-12 (<i>as applicable</i>)	Continuous Testing Time: 70 minutes	State – When a newly enrolled student has responded with a language other than English on any part of the Home Language Survey, the student is screened for ESL services with the WIDA-ACCESS Placement Test (W-APT). The screener is only given once in the educational career of the EL.	The scores on the screener determine: <ul style="list-style-type: none"> ● if the student will be classified as EL ● the minimum amount of service the EL will receive Results are not used for grades.
RTI Universal Screener Grades K-12	August 15 – August 26 January 5 - 20 May 1 – 19 Testing Time: 40 minutes	State – The purpose of a universal screener is to determine performance to the grade-level skills and is the initial assessment to identify students who are potentially in need of additional levels of support.	Screening results are not typically distributed outside the school due to their formative nature, but parents may request the information from the school as needed. Results are not used for grades.
Progress Monitoring Assessments K-12 (<i>as applicable</i>)	Continuous Testing Time: 1-30 minutes depending upon subtest taken.	State – Progress monitoring tools provide, nationally normed skills-based assessments utilized for students who score below the 26 th percentile on the Universal Screener.	Parents will receive notification if the results of the universal screening process indicate their child meets the requirements for additional academic support and intervention(s). Results are not used for grades.
